LIABILITY

- Industry-leading per occurrence limit for general liability, auto liability and employer's liability
- Also includes public officials' errors & omissions, employment practices, law enforcement and employee benefits
- Deadly weapon response coverage and sexual misconduct liability coverage



PROPERTY

- \$1 billion per occurrence limit
- Coverage includes: buildings, watercraft, athletic fields, contents, animals, fine arts, vehicles, trees and greens, business interruption, mobile equipment, landscaping, service interruption, errors and omissions, course of construction, and terrorism
- \$100 million per occurrence boiler/machinery limit
- \$2 million fidelity and crime limit



WORKERS' COMPENSATION

- Statutory limits
- \$6 million limit for employer's liability



POLLUTION LIABILITY

- Liability coverage for bodily injury and property damage
- Remediation coverage for cleanup costs
- \$5 million per occurrence limit
- \$30 million aggregate limit



INFORMATION SECURITY AND PRIVACY

- Includes cyber liability, privacy notification costs, data protection and business interruption
- \$2 million limit for cyber liability, including:
 - Data breaches
 - Cyber-dependent business loss
 - eCrime



OUTBREAK EXPENSE

- Up to \$25,000 per day coverage for facility closure by a public health official due to contagion/communicable disease
